2019 ANNUAL MEETING MINUTES

ANNUAL MEETING OF THE ASSOCIATION MEMBERS LOGAN COUNTY COOPERATIVE POWER & LIGHT ASSOCIATION, INC.

June 11, 2019

The 83rd Annual Meeting of the members of the Logan County Cooperative Power & Light Association, Inc. was held on Tuesday, June 11, 2019 at 7:00 p.m. in the warehouse of the Association's headquarters facility located at 1587 County Road 32 N., Bellefontaine, Ohio 43311, pursuant to notice duly given to all members.

The meeting was called to order by Chairman Douglas Comer, who presided, and who welcomed the members, declared that a quorum was present, and lead those in attendance in reciting the Pledge of Allegiance.

The Chairman introduced Mr. Michael Wilson, Director of Communications, who presented to the three members of the Logan County Fair Board present at the meeting, a check in the amount of \$5,000.00 as a donation by the Logan County Electric Cooperative to the Fair Board for use in the upcoming renovation of the show arena located at the Logan County Fairgrounds.

The Chairman gave special recognition to Tom Alban, Vice President, Power Generation for Buckeye Power, Inc., and Rebecca Seum, Associate Editor of *Ohio Cooperative Living*, and representatives of The Richwood Bank.

The Chairman then introduced the current Board of Trustees as follows: Lanny Davis – District I; Jerry Fry – District 2; Jim Rice – District 3; Janet Blank – District 4; Doug Comer – District 5; Scott Hall – District 6; and Warren Taylor – District 7. Mr. Comer also acknowledged all LCEC employees who were present for the meeting.

Upon Motion, duly seconded and carried, the reading of the official notice of the meeting was dispensed with. Notices of the time and place of the Annual Meeting and ballots had been mailed to each member, with an additional notice of the Annual Meeting having been published in the June edition of the *Ohio Cooperative Living Magazine*. An affidavit concerning the notice of said meeting, signed by Lanny Davis, duly elected Secretary/Treasurer, was filed with the Annual Minutes.

Upon motion, duly seconded and carried, the reading of the Minutes of the Annual Meeting of June 12, 2018 was dispensed with. The Chairman then called for any additions or corrections to the minutes and, there being none, upon motion, duly seconded and carried, the minutes of the Annual Meeting of June 12, 2018 were accepted as printed and distributed at the meeting.

The Chairman then introduced Mr. Rick Petty, General Manager, who on behalf of Mr. Jim Naderer, Secretary of the Nominating Committee, presented the Nominating Committee Report, introducing the members of the Nominating Committee as follows: Jana Knief – District I; Keith Stoner - District 2; Ron Milton - District 3; Jim Naderer – District 4; Chuck Strayer – District 5; Scott Gregory - District 6; and Kevin Barth - District 7. Mr. Petty advised that the Nominating Committee met on January 15, 2019 to interview the candidates who submitted Trustee interest cards for Districts 5, 6 and 7. He thanked the candidates for volunteering to be on the ballot and introduced them as follows: District 5- Doug Comer and Greg Kreisher; District 6 - Scott Hall; District 7 - Warren Taylor and Gary Ginter.

Mr. Douglas M. Smith of Smith, Smith, Montgomery & Chamberlain, LLC was then called upon to announce the results of the election as tallied and certified by E. Space Communications. He reported that there were 547 ballots cast in the election, representing approximately 13.98% of the eligible voting members, and that Doug Comer

was elected as District 5 Trustee; and that Scott Hall was elected as District 6 Trustee; and that Warren Taylor was elected as District 7 Trustee. He congratulated Mr. Comer, Mr. Hall and Mr. Taylor and administered the oath of office to Mr. Comer, Mr. Hall and Mr. Taylor. Mr. Comer, Mr. Hall and Mr. Taylor were required to sign an Oath of Office, which Oath was filed with the annual minutes.

The Chairman then presented the 2020 Nominating Committee as appointed by the Board of Trustees and to be affirmed by the membership as follows: Kevin Knief – District 1; Keith Stoner – District 2; Ron Milton – District 3; Jim Naderer – District 4; Chuck Strayer – District 5; James Grider – District 6; and Janet Detrick – District 7. Upon motion, duly seconded and carried, without opposition, the 2020 Nominating Committee was affirmed.

The Chairman then introduced General Manager Rick Petty and Vice President of Power Generation for Buckeye Power, Tom Alban, regarding the Buckeye Report. Before Mr. Alban gave his report, a video from Pat O'Loughlin, President and CEO of Buckeye Power, was shown to those in attendance. Mr. Alban provided an update regarding the transfer of operations at the Cardinal Plant from AEP to Buckeye Power and commented on the new challenges to Buckeye presented by running the Cardinal Plant. Mr. Alban touched on certain accomplishments by Buckeye Power and the Ohio Electric Cooperatives, including the project in Guatemala, Operation Roundup at the electric cooperatives, and the consistent payment by the Ohio Electric Cooperatives of capital credits to their respective members.

The Chairman then introduced the Director of Finance & Accounting, Tiffany Stoner, to present the 2018 Financial Highlights Report. Ms. Stoner noted total operating margins for 2018 of \$1,093,000.00, total assets in excess of 40 million dollars with total member equity of 49.48%. Ms. Stoner's report also included a breakdown of kilowatt sales to members by member class and a breakdown of operating expenses for the year. Ms. Stoner noted that \$536,406.00 in patronage capital was retired in 2018 and that life-to-date patronage capital retirement stands at \$10,582,884.00.

Ms. Stoner provided a brief review of the independent auditor's report prepared by Rea & Associates in March, 2019, noting that in the opinion of Rea & Associates, the consolidated financial statements fairly present the respective position of Logan County Cooperative Power & Light Association, Inc. as of December 31, 2018 and 2017.

The Chairman then introduced LCEC General Manager, Rick Petty, to present his annual report. Mr. Petty began his report by noting that he will be retiring as President/General Manager of LCEC effective January, 2020 and that tonight's report will be his last as President/General Manager. Mr. Petty played a few excerpts from the May 9, 2019 Telephone Town Hall Meeting and introduced Mr. Aaron Newland as the newest journeyman lineman to join the LCEC crew. Upon completion of his report, Mr. Petty received a standing ovation from those present.

The Chairman then acknowledged the efforts of Mr. Michael Wilson and all of the employees at the Cooperative who took part in making the 83rd Annual Meeting a success. Mr. Wilson then requested that those present complete the Annual Meeting Survey enclosed in their registration packet and that each member present would have the opportunity to select either a zippered bag or 25' long 12-gauge extension cord as they exited the meeting.

There being no further business, the Chairman declared the meeting adjourned.

BOARD NOMINATIONS AND THE NOMINATING COMMITTEE

SECTION 4. Nominations.

It shall be the duty of the Board to appoint a committee on nominations consisting of not less than five (5) nor more than eleven (11) members who shall be selected so as to ensure equitable representation on the committee to the geographic areas constituting the service area of the Cooperative. The committee on nominations shall be confirmed by the members present at a meeting at the annual meeting of members. No person shall serve on the Nominating Committee more than three (3) consecutive years. The committee shall prepare at least one hundred twenty (120) days before the meeting of the members a list of nominations which shall include no more than two candidates from each district to be elected.




Report on the Consolidated Financial Statements

Opinion




Operating Expenses
